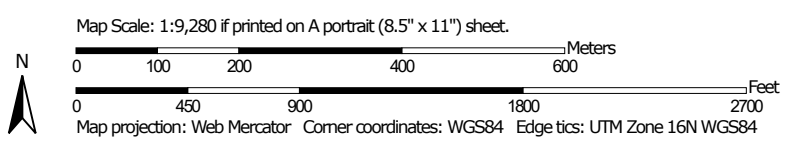


Soil Map—Marion County, Kentucky
